For very minor repairs, L&I may not require a full permit. This typically includes:

- **Simple Repairs:** Replacing a few shingles that blew off in a storm.
- **Gutter Cleaning:** Routine maintenance is not a construction project.

However, the line between "repair" and "renovation" can be blurry. A good rule of thumb is: if the repair is small and doesn't involve structural components or altering the roofline, you may be fine. But always, *always* check with a professional first.

- 3. **It Protects Your Home's Value:** When you sell your home, a lack of a permit for a new roof can be a major red flag for buyers and inspectors, potentially delaying your sale.
- 4. **It Validates Your Warranty:** Many shingle manufacturers will void their material warranty if the roof was not installed to code or by a licensed professional. The permit is proof.

Who is Responsible for Pulling the Permit?

Your contractor.
